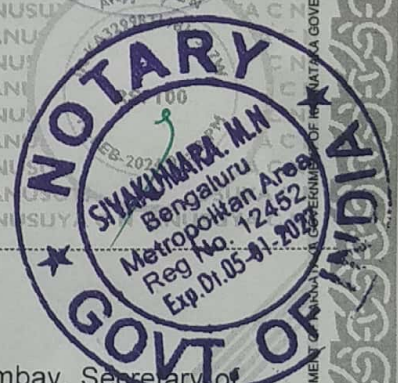
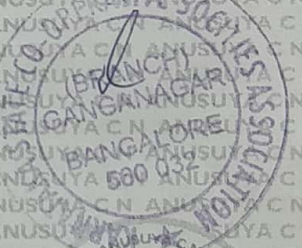

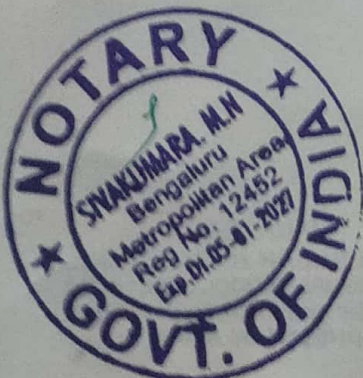
3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
